Reasons: In Q1 2025, profit after tax increased by 18,70% compared to Q1 2024, mainly due to the following reasons:

- Revenue reached only 35% because there was no revenue from stone mining activities; however, the cost of goods sold decreased significantly compared to Q1/2024, resulting in an increase of 282,08% in gross profit.
- Financial expenses and other expenses also decreased compared to the same period.
- In Q1/2025, the Company recorded income from the liquidation of a concrete mixer truck.
