Explanation:

- (1) The Separate Business Result of the Company for 1st quarter 2025 recorded a loss of VND 15.162 billion, which is an improvement compared to the same period last year.
- (2) The business performance improved by VND 15.360 billion compared to 1st quarter 2024 (exceeding the 10% threshold). The reasons are as follows:

Firstly, although the shipping market has not fully recovered from its difficulties, there have been positive developments since mid-quarter 2024.

Freight rates and charter hire rates for the type of vessels owned by the Company have improved.

Seizing this opportunity, the Company actively combined self-operated shipments and time-charter contracts, resulting in an increase in revenue during the reporting period by VND 18.726 billion (up by 39.7%), while cost of goods sold rose by only VND 5.173 billion.



These are the two main factors contributing to the improved business result: reducing the loss to VND 15.162 billion in 1st quarter 2025 compared to 1st quarter 2024, with a positive difference of VND 15.360 billion (over 10%) as shown in the table above.

Future Plans for Business Improvement:

Dong Do Maritime Joint Stock Company will continue to proactively capture favorable market opportunities, strengthen efforts to find efficient ways to operate its fleet, and seek reputable customers and cargo sources to further enhance freight rates and revenue.

Additionally, the Company will intensify efforts to save on operating and management expenses to increase the efficiency of its production and business activities. At the same time, the Company will also work to expand into additional service activities to improve its overall business results and cash flow.
