+ Revenue in Q1/2025 decreased by 1,820 billion VND (equivalent to 8,22%) compared to Q1/2024, while cost of goods sold increased by 0,389 billion VND (equivalent to 5,06%). Selling expenses decreased by 0,146 billion VND (equivalent to 11,16%), and general and administrative expenses increased by 3,251 billion VND (equivalent to 257,69%) compared to Q1/2024.

+ Financial revenue in Q1/2025 increased by 1,111 billion VND (equivalent to 291,71%), while financial expenses decreased by 2.543 billion VND (equivalent to 107,15%) compared to Q1/2024

- + Loss from joint ventures and associates decreased by 0,112 billion VND (equivalent to 98,91%) compared to Q1/2024
- + Other income in Q1/2025 increased by 0,495 billion VND (equivalent to 6.703,24%), while other expenses increased by 0,128 billion VND (equivalent to 100,4%) compared to Q1/2024

Due to the above factors, post-tax profit in Q1/2025 decreased by 0,23% compared to Q1/2024, And a net profit after tax was recorded for Q1/2025 Sincerely.
