**In Q2/2025 compared to Q2/2024, profit after corporate income tax decreased by VND 345.262.927, and profit before tax decreased by VND 429.436.259.**

Although the total operating revenue of the Company in Q2/2025 grew significantly (an increase of VND 22 billion compared to the same period last year), the decrease in real

estate business revenue led to a reduction in the Company's operating profit compared to the same period last year.

Real estate business revenue in Q2/2025 reached VND 3,411 million, whereas in Q2/2024 it was VND 4,352 million, a decrease of VND 941 million.
