*Re: Explanation of profit after tax  
difference in Quarter 2, 2025*

Pursuant to Circular No. 96/2020/TT-BTC dated 16/11/2020 of the Ministry of Finance guiding the disclosure of information on the stock market.

Based on the Company's Financial Statements in Quarter 2, 2025 with the target of Profit after tax fluctuating by over 10% compared to the same period in 2024, Petrolimex Haiphong Transportation and Service Joint Stock Company (Security code: PTS) would like to explain as follows:

*1. Parent Company Financial Statements:*

*2. Consolidated Financial Statements:*

The profit after tax on the Q2/2025 financial statements of the Parent Company reached VND 1,188,451,713 (an increase of VND 1,676,016,567 or 343.8% compared to the same period in 2024), mainly due to:

+ Transport revenue in Q2/2025 reached VND 50,738,338,875, a decrease of VND 1,525,963,902 compared to the same period in 2024, as vessels PTS Hai Phong 03, PTS 24, PTS 18, and PTS 28 underwent scheduled dry-docking repairs. However, several cost items declined due to full allocation in previous periods and reduced cost norms, resulting in increased profit from transport operations.

+ Financial expenses decreased due to a reduction in late payment interest to Petrolimex Haiphong Co., Ltd., lower outstanding loan principal, and decreased provision expenses for investment losses in subsidiaries.

*3. Regarding the consolidated financial statements:*

Revenue from the waterway vessel repair and new-build segment (entirely operated by the subsidiary) reached only VND 521,050,099. Consequently, the subsidiary incurred a loss of VND 247,533,791 due to the continued sluggishness in the waterway vessel repair and new-build market.

After consolidation, the Company's total profit after tax in Q2/2025 reached VND 1,248,873,504, an increase of VND 1,685,679,491 or 386% compared to the same period in 2024.
