Prosperity and Growth Commercial Joint Stock Bank (PGBank) hereby submits the report on corporate governance for the first half of 2025 as follows:

#### I. Activities of the General Meeting of Shareholders (GMS).

- On April 24, 2025, PGBank convened its Annual General Meeting of Shareholders (AGM) for 2025 to approve key matters such as: the 2025 financial plan; the selection of an independent audit firm; the increase of PGBank's charter capital; the election of the Board of Directors (BOD) and Supervisory Board (SB) for the 2025–2030 term; and other matters under the authority of the GMS.
- The AGM was held in an in-person format and received active participation from shareholders, with many contributions and suggestions for the Bank's development plans.

#### 2. Information on Meetings of the Board of Directors

In the first six months of 2025, the Board of Directors (BOD) of PGBank convened 06 BOD meetings. All meetings were conducted in accordance with regulations and attended by members of the BOD and the Supervisory Board (SB) of the Bank. Details are as follows:

In addition to the above meetings, the Board of Directors regularly exchanged views and provided guidance on the Bank's activities through written consultations.

#### 3. Supervisory Activities of the Board of Directors over the Executive Board

- Directed the implementation of the Restructuring Plan in conjunction with the handling of non-performing loans (NPLs) for the period 2021–2025. Ensured thorough resolution of existing issues, violations, and potential risks in banking operations. Accelerated the settlement of NPLs, improved credit quality, and actively prevented and minimized the emergence of new NPLs. Monitored and addressed existing NPLs, potential problem loans, and NPLs transferred to the Vietnam Asset Management Company (VAMC). Targeted that by the end of 2025, the total of on-balance-sheet NPLs, unresolved NPLs sold to VAMC, and potential loans turning into NPLs of PGBank will be maintained at below 3%.
- Directed the successful organization of the 2025 Annual General Meeting of Shareholders. Accordingly, the AGM approved key resolutions including: the 2025 financial plan; the selection of an independent audit firm; the increase of PGBank's charter capital; the election of the Board of Directors (BOD) and Supervisory Board (SB) for the 2025–2030 term; and other matters within the authority of the AGM.
- Directed the completion of PGBank's charter capital increase plan in accordance with Resolution No. 02/2024/NQ-AGM dated 20/04/2024, raising the charter capital from VND 4,200 billion to VND 5,000 billion.
- Approved the implementation of the charter capital increase plan in 2025 through a share issuance to existing shareholders and dividend payments, aiming to supplement capital resources for operations in line with the 2025–2030 Development Strategy.
- Approved the renovation and relocation of PGBank branches and transaction offices to more favorable locations with larger premises, enhancing brand identity with a more professional and modern image for customers and partners.
- Strengthened senior human resources governance, improved employee benefit schemes, and promoted talent development, attraction, and retention. In the first half of 2025, the Board of Directors approved the appointment of one additional Deputy CEO: Mr. Phuong Tien Dung was appointed Deputy CEO cum Head of Appraisal and Approval Division, responsible for the appraisal, evaluation, and approval of loans in accordance with

regulations. Simultaneously, the BOD also approved the resignation of Mr. Nguyen Trong Chien – Deputy CEO, effective from June 15, 2025.

- Held regular and ad-hoc BOD meetings to receive reports from the Executive Board on the Bank's operations, in addition to maintaining a supervisory regime based on delegated authority.
- Directed periodic and ad-hoc inspections, reviews, and evaluations of business units' operations, identified difficulties and obstacles, and provided timely instructions for the operations of individual branches.
- In general, during the first six months of 2025, the Board of Directors effectively supervised and directed the Executive Board in accordance with the Bank's strategic orientations and goals. The BOD provided guidance to the Executive Board on business planning, institutional development, and enhancing competitiveness (by building a streamlined and efficient operating model, reducing procedures, investing in technology, and developing high-quality human resources). All directives from the BOD were actively implemented by the Executive Board to fulfill the Bank's business plans and achieved notable growth.

#### 4. Activities of Committees under the Board of Directors.

The Board of Directors (BOD) of PGBank comprises the Human Resources Committee, the Risk Management Committee, other Councils/Committees under the BOD, and the Office of the BOD. These bodies perform advisory and supporting functions for the BOD in accordance with applicable laws and internal regulations of PGBank from time to time. Specifically:

- Human Resources Committee: Advises the BOD on personnel-related matters arising during the procedures for election, appointment, dismissal, and removal of members of the BOD, the Supervisory Board, Executive Officers, and senior managers of PGBank under the authority of the BOD. It also advises on the issuance of internal regulations under the BOD's jurisdiction regarding salary policies, remuneration, bonuses, human resources regulations, training, and other HR-related matters.
- Risk Management Committee: Advises the BOD on the issuance of processes and policies within its authority relating to risk management in banking operations. It conducts analyses to provide early warnings on the Bank's safety levels in response to potential risks and recommends preventive measures for both short-term and long-term risk exposures.
- Credit Risk Resolution Council: Approves or decides on loan classification, off-balance-sheet commitments, provisioning, and use of provisions for credit risk handling across the system; approves consolidated system-wide reports and results of debt recovery using provisions, including results of collateral disposal, and clearly defines the basis for such approvals; decides or approves measures to recover debts that have been covered by provisions, including collateral handling across the entire system.
- Office of the Board of Directors: Acts as an advisory and supporting unit to the BOD in executing its leadership and governance functions over the Bank's operations in accordance with legal regulations and PGBank's Charter.

The number of members of the Supervisory Board (SB) of PGBank during the first six months of 2025 was four (04). PGBank plans to elect an additional SB member for the 2025–2030 term at the Extraordinary General Meeting of Shareholders in 2025.

#### 1. Meetings of the Supervisory Board

In the first six months of 2025, the Supervisory Board of Prosperity and Growth Commercial Joint Stock Bank (PGBank) convened 20 meetings to discuss and reach consensus on matters within its authority, functions, and responsibilities. All meetings were held in accordance with legal procedures and attended by a quorum sufficient to conduct the meetings. During these meetings, SB members deliberated and reached consensus on issues under the SB's jurisdiction and responsibilities, with voting ratios in compliance with legal regulations, the Bank's Charter, and the Supervisory Board's Organization and Operation Regulations. Minutes of the meetings were recorded and archived by the SB in accordance with its operational regulations and serve as the basis for the SB to perform its duties and exercise its powers.

The Head and all members of the Supervisory Board are full-time positions; therefore, there were no matters requiring written consultation.

### 1. Supervisory Activities of the Supervisory Board over the Board of Directors, Chief Executive Officer, and Shareholders

#### 1.1 Supervisory Activities over the Board of Directors

- The Supervisory Board (SB) monitored the implementation by the Board of Directors (BOD) of the resolutions of the General Meeting of Shareholders (GMS) in accordance with the approved roadmap.
- The SB oversaw the BOD's performance in supervising senior management, specifically the Chief Executive Officer (CEO), in implementing GMS and BOD resolutions; monitored the development and implementation of the internal control system; and the formulation and enforcement of risk management policies through internal audit and supervisory activities. It also supervised the approval and execution of investment projects involving the purchase and sale of fixed assets, contracts, and other transactions of the Bank as stipulated in the 2024 Law on Credit Institutions.
- The SB monitored the BOD in organizing and implementing remedial actions in response to recommendations from the State Bank of Vietnam's Inspectorate, independent auditors, internal auditors, and other external state inspection agencies concerning the activities and responsibilities of the BOD.
- The SB participated directly in BOD meetings, received all documents and dossiers submitted to the BOD either during physical meetings or through written consultations, allowing it to review and comment on compliance with legal regulations for matters under the BOD's authority.

Internal audit results and the SB's recommendations were submitted to the BOD to ensure that the BOD was informed of issues identified and could issue directives for matters under its authority. The internal audit function, which acts as the supporting unit of the SB, also monitored the BOD's progress in implementing recommendations issued by the SB and internal audit.

#### 1.2 Supervisory Activities over the Chief Executive Officer

- Supervised the performance of senior management oversight by the CEO and units under the CEO's authority through internal audit activities.
- Monitored the CEO's implementation of corrective actions based on recommendations
  from the State Bank of Vietnam's Inspectorate, independent auditors, internal auditors,
  and other external state inspection agencies concerning the operations and
  responsibilities of the CEO.
- Through supervisory and internal audit activities, monitored the organization and implementation of business operations, management, administration, and risk management conducted by units or individuals under the CEO's authority; reviewed the Bank's semi-annual and annual financial statements.
- Participated in and provided comments (where necessary) at Executive Board meetings or other related meetings held by the Executive Board.
- Internal audit results and the Supervisory Board's recommendations were submitted to the CEO to ensure awareness of identified issues and to enable the CEO to provide instructions for matters under their authority. The internal audit department, as the supporting unit of the Supervisory Board, monitored the implementation by the CEO of recommendations issued by the SB and internal audit.

# 2. Coordination between the Supervisory Board and the Board of Directors, Chief Executive Officer, and Other Management Positions

- The coordination mechanism between the Supervisory Board (SB), the Board of Directors (BOD), and the Chief Executive Officer (CEO) strictly adheres to legal regulations and PGBank's internal policies, with the shared objective of ensuring the sustainable development of PGBank.
- The BOD, SB, and CEO regularly coordinate activities in accordance with internal regulations on coordination mechanisms during the performance of their respective functions and responsibilities.
- The SB frequently participates in BOD meetings and CEO's executive briefings. The SB is provided with information and documents related to governance and management activities of both the BOD and CEO.

Through its supervisory activities, the SB has offered feedback and recommendations to the BOD and CEO regarding measures to strengthen control and risk management, ensuring compliance with applicable laws and internal regulations. These recommendations from the SB have been reviewed and acted upon by the BOD and CEO, with instructions issued to relevant units for implementation.
