3. Supervising the Board of Management by the Board of Director:

- The supervisory activities of the Board of Directors (BOD) over the Executive Body are carried out strictly and periodically, in compliance with the Charter on the organization and operation of the Corporation, the applicable laws and regulations, as well as the Resolutions and Decisions of the General Meeting of Shareholders (GMS) and the Corporation's BOD.
- Directed the organization of the 2025 Annual General Meeting of Shareholders (AGM) on April 25, 2025, and issued Resolution No. 04/NQ-DHCD dated April 25, 2025.
- In the first six months of 2025, the Corporation's BOD consistently emphasized the guideline of maintaining cash flow for business operations, sustaining production capacity amid a highly volatile market. The BOD convened 6 meetings and issued 7 Resolutions, mainly focusing on directing and supervising the operations of the Executive Body.
- During annual and extraordinary BOD meetings, along with mid-term review meetings, and communications via phone and email, the BOD required the Executive Body (EB) to report and analyze the Corporation's overall business and production situation, human resources management and training, finance, market development, internal control, performance evaluation, identification of existing issues, and timely implementation of solutions and corrective actions, as follows:

• About the Yarn Sector:

- Raw Material Procurement: Cotton prices fluctuated widely, making it difficult to secure raw materials for production. It is necessary to carefully balance procurement to ensure sufficient supply with suitable types for production, aiming for a high proportion of U.S. cotton, avoiding long-term purchases and stockpiling.

Market and sales:

- + The sales market faced many difficulties, with unfavorable yarn price fluctuations compared to cotton prices.
- + The Corporation maintained a diverse and familiar customer base and, in the first six months, developed additional clients from Japan, South Korea, Chile, and the Philippines. It is necessary to continue maintaining existing markets and expand domestic customers through large, stable orders for defense and security.

- Production management:

- + Orders were received as planned to mobilize equipment, but due to market difficulties, many times orders could not be confirmed early, making production scheduling challenging. Orders remained small and irregular, requiring frequent production technology changes.
- + Severe labor shortages at factories caused difficulties in arranging production.
- + Invest in additional highly automated machinery and equipment to reduce labor requirements and increase productivity.
- + Balance product mix to suit production lines, existing labor, and market demand, maximizing machine efficiency for the most effective production plan (e.g., recycled yarn production).
- + Implement cost-saving measures, reduce raw material consumption, energy usage, spare parts, and auxiliary materials

- Quality:

- + Maintain quality standards to meet customer requirements.
- + Focus on industrial sanitation (VSCN) to ensure no negative impact on the quality of semi-finished products and yarn

• About the Garment Sector:

- The Board of Directors (BOD) closely directed production management to enhance productivity, recruit skilled labor, reorganize and restructure the workforce, and reduce indirect staff.
- The order plan was sufficient for production; however, at certain times, delays in the arrival of raw materials and supplies affected productivity. Additionally, due to U.S. tariff policies, some customers required changes to tags and prices, causing the factories to spend extra effort on replacements, incurring additional labor costs.

Delivery schedules were also postponed or delayed, negatively affecting revenue in the first six months of 2025.

- The Corporation received special attention and support from Vinatex and assistance from Hue Textile and Garment Joint Stock Company, which significantly improved productivity, quality, and management, delivering positive results.

• About human resources:

- Labor turnover fluctuated significantly, requiring the Corporation to supplement the wage fund to ensure employees' livelihoods and to develop policies to retain workers.
- Develop internal human resources following the principle of Training Retention Development.
- Innovate the human resources communication strategy.
- Reorganize and restructure the organizational model to achieve flexible and effective operations.
- Digitize the management, labor, and payroll systems.
- Foster and build a strong corporate culture.

About finance:

- Control revenues and expenditures, ensuring effective cash flow balance.
- Arrange sufficient capital sources for business operations and investments.
- Manage working capital, including inventories and receivables.
- Respond promptly to exchange rate fluctuations.
- Effectively control costs.
- Gradually implement digital transformation for production management.

About Risk management and investment:

- Closely monitor macroeconomic and domestic developments that may impact the yarn and garment markets, especially U.S. tariff policies.
- Analyze and assess the market, sales performance, inventory control, and monitor financial conditions to balance business operations, sales, and cash flow for optimal efficiency.

- Invest in highly automated machinery and equipment to reduce costs, minimize labor requirements, and enhance productivity. Renovate factories to create a green, clean, and pleasant working environment
