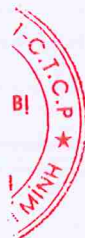

Reasons:



Profit after tax on the consolidated financial statements for Quarter II/2025 decreased by 10.32% compared to the same period last year.

The decrease was mainly due to a 31.78% decline in revenue from the book segment and a 9.42% decrease in teaching activities compared to the same period.
